## MILFORD TOWNSHIP ORDINANCE #08

AN ORDINANCE PROVIDING FOR THE ERECTION OF STOP SIGNS AT VARIOUS NAMED INTERSECTIONS

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Milford Township, Bucks County, Pennsylvania, at a meeting duly held at which a quorum was present and acting, an it is hereby ordained and enacted by the same, viz:

SECTION 1. The following intersections located in Milford Township are hereby declared to be stop intersections, and official stop signs shall be erected or have already been erected and are hereby ordained in such a position as to face traffic approaching the second-named street in the direction or directions hereby indicated. All vehicles approaching the intersection upon the first named street in the direction or directions hereby indicated in each case shall come to a full stop, within a reasonable distance, before entering said intersection:

- (a) Wentz Road and Weiss Road, facing northbound and south bound traffic;
- (b) Wieand Road and Brick Tavern Road, facing northbound and southbound traffic;
- (c) Wright Road and Old Woods Road, facing northbound and south bound traffic;
- (d) Church Road and Brinkman Road, facing eastbound and westbound traffic;
- (e) Fennel Road and Fels Road, facing eastbound and westbound traffic;
- (f) Zipp Road and Old Plains Road, facing northbound and south bound traffic;
- (g) Old Plains Road and Carver's Hill Road, facing eastbound and westbound traffic;
- (h) Erdman Road and Keiper Road, facing eastbound and westbound traffic;
- (i) Doerr Road and Canary Road, facing northbound and southbound traffic; and
- (j) West Swamp Road and Bauman Road, facing northbound and south bound traffic.

SECTION 2. If any part of this ordinance shall be declared invalid by a court of competent jurisdiction, such invalidity shall not affect any other part of this ordinance. It is hereby declared to be the legislative intent that this ordinance would have been enacted had such invalid portion of a section not have been included herein.

SECTION 3. All other ordinances, or parts of ordinances inconsistent herewith are hereby repealed insofar as such inconsistency may exist.
