

**ORDINANCE #38**

AN ORDINANCE ORDAINING AND OPENING ELM AVENUE WHICH EXTENDS IN AN EAST-WEST DIRECTION FROM THE EAST SIDE OF ALLENTOWN ROAD, L.R. 09108, A DISTANCE OF APPROXIMATELY 582 FEET, AS A PUBLIC TOWNSHIP ROAD OF MILFORD TOWNSHIP, BUCKS COUNTY, PENNSYLVANIA; DIRECTING THAT A COPY OF THE ORDINANCE, TOGETHER WITH A DRAFT OR SURVEY OF THE ROAD, BE FILED WITH THE CLERK OF COURTS; PROVIDING AN EFFECTIVE DATE AND REPEALING INCONSISTENT ORDINANCES OR PARTS THEREOF

WHEREAS, in the judgment of the Supervisors of Milford Township, it is necessary that Elm Avenue, which lies wholly within the Township boundaries, be ordained and opened as a public township road; and

WHEREAS, the said road to be ordained and opened abuts onto lands now or late of the following named persons: William W. and Lorraine A. Astfalk, Donald and Esther Shelly, Richard F. and June A. Roth, William Mackey, III, and Patricia Mackey, Grace E. Crouthamel, James B. and Vada C. Spangler, Marlin E. and Elaine H. Cobb, John C. and Elizabeth Ozkowski, Alfonso J. and Barbara Lewandowski, Gerald B. and Joan C. Hangey, Joseph and Lucy G. Anderson, Nhu Mai Thi Ng, and Silvene and Stella Bracalente, being the property owners affected by the ordination and opening of the said road; and

WHEREAS, after due notice having been given, a hearing was held of which ten days' written notice was given to the property owners affected thereby, and at which affected property owners and interested parties were permitted to be heard.

BE IT AND IT IS HEREBY ORDAINED by the Supervisors of Milford Township, under the authority of The Second Class Township Code as follows:

SECTION I. That Elm Avenue, being a road extending in an east-west direction off the east side of Allentown Road, L. R. 09108, approximately 330 to 380 feet south of the southerly right of way line of Texas Eastern Transmission Corporation pipeline, and being fifty feet in width, and approximately five hundred eighty-two (582) feet in length, from Allentown Road and abutting onto properties now or late of the following persons: William W. and Lorraine A. Astfalk, Donald R. and Esther Shelly, Richard F. and June A. Roth, William Mackey, III, and Patricia Mackey, Grace E. Crouthamel, James B. and Vada C. Spangler, Marlin E. and Elaine H. Cobb, John C. and Elizabeth Ozkowski, Alfonso J. and Barbara Lewandowski, Gerald B. and Joan C. Hangey, Joseph and Lucy G. Anderson, Nhu Mai Thi Ngo, and Silvene and Stelle Bracalente, and being more fully depicted on a plan of Silvene Bracalente dated April 5, 1976 and recorded in the Recorder of Deeds Office of Bucks County on June 3, 1976 in Plan Book 143, page 37, is hereby ordained and opened as a public road of Milford Township.

SECTION II. A copy of this Ordinance, together with a draft or survey showing the location and width thereof, is directed to be filed in the office of the Clerk of Court of Common Pleas, Criminal Division, Bucks County, Pennsylvania.

SECTION III. This Ordinance Shall become effective thirty (30) days after the filing thereof and the plan or survey referred to in Section II hereof.

SECTION IV. All ordinances or parts of ordinances inconsistent herewith, are hereby repealed.
